

IEEE Publication Policies

The IEEE Transactions on Vehicular Technology (TVT) follows the IEEE publication guidelines given in the IEEE Publication Services and Products Board Operations Manual, which is available online at

Authors are responsible for reading and adhering to these guidelines. A submission must be withdrawn immediately if its author(s) are unable to comply with any of the guidelines. Items specific, but not limited, to these principles are highlighted in the following.

Policy on Authorship (in Section 8.2.1)

- Authorship and co-authorship should be based on a substantial intellectual contribution. It is assumed that all authors have had a significant role in the creation of a manuscript that bears their names.
- Co-authors have responsibility for work submitted under their names. They should remain knowledgeable so far as possible in the contents and status of the manuscript, including the nature of any revisions.

Policy on Multiple Submissions and Prior Publication (in Sections 8.1.7 and 8.2.4F)

- A submission to TVT must present original work which has not appeared/accepted elsewhere for publication, or has not been concurrently submitted to another journal/conference publication. The author(s) should inform the Editor of any multiple publications and/or submissions of the same work.
- If a new submission is based on a published/accepted/submitted conference paper(s), the previous work must be cited in the journal submission, and the new submission should offer substantive novel contributions beyond the previous work. Please include a summary of new contributions and previous conference paper(s) in the TVT submission. We do not accept any submission that is basically the same as a conference paper or papers in technical contents.
- Both concurrent submission(s) to other journals/conferences and failure to properly cite previous work are considered a serious breach of professional conduct, and the author or authors are subject to corrective actions depending on his/her/their previous violations. The actions include
 - immediate rejection of the TVT submission,
 - a reminder that the practice is considered inappropriate scholarly practice,
 - a requirement to submit an apology to the TVT Editor,
 - suspension of publication in the IEEE publication where the offense took place for 1 year.

Policy on Plagiarism (in Section 8.2.4D)

Plagiarism includes, but is not limited to,

- uncredited copying of someone else’s work,
- using someone else’s material without clear delineation or citation, and
- uncited reuse of an author’s previously published work.

Plagiarism in any form is unacceptable and is considered a serious breach of professional conduct, with potentially severe ethical and legal consequences. IEEE defines five levels or degrees of plagiarism, and specifies appropriate corrective actions corresponding to each level of misconduct.

Policy on Electronic Posting (in Section 8.1.9)

IEEE allows its authors to post the preprint (a draft manuscript), the submitted manuscript, and the accepted version of an article on the author’s personal web site, his/her employer’s site, or another site that invites comment for the purpose of developing the work.

- Upon submitting an article to the IEEE for review and possible publication, the author must add the following notice to the first screen of any of his/her previously posted electronic preprint versions of this paper: “This work has been submitted to the IEEE for possible publication. Copyright may be transferred without notice, after which this version may no longer be accessible.”
- When IEEE accepts the work for publication, the author must add the following IEEE copyright notice to any previously posted versions of the particular paper submitted and provide IEEE with the electronic address (URL, ftp address, etc.) of the primary electronic posting: “© 20xx IEEE. Personal use of this material is permitted. Permission from IEEE must be obtained for all other uses, including reprinting/republishing this material for advertising or promotional purposes, collecting new collected works for resale or redistribution to servers or lists, or reuse of any copyrighted component of this work in other works.”
- When IEEE publishes the work, the author must replace the previous electronic version of the accepted paper with either 1) the full citation to the IEEE work with Digital Object Identifier (DOI) or link to the paper abstract in IEEE Xplore®, or 2) the accepted version¹ only (not the IEEE-published version²), including the IEEE copyright notice and full citation, with link to the published paper in IEEE Xplore®.
